In addition to Annual Membership Fees: All Members (Other than Juniors, Reciprocal & Country Members) are required to purchase House Support Points (**HSP**) (Money on your membership card to spend back at the club), HSP Expire 31 March. New Members who join between 1 December & 31 March will be eligible for a pro-rata discount on House Support Points.

Club Boat Register
