House Support Points (HSP)

In addition to Annual Membership fees, all members (other than Country and Junior members) are required to purchase House Support Points (HSP) which are credited onto their Membership account and accessed by the Membership card, once per year—in April. These are redeemable at the Club for Merchandise, Food and Beverages and expire on the 31st March if not redeemed. New Members who join between 1 December and 31st March will be eligible for a pro-rata discount on House Support Points.

Club Boat Register

All craft either moored, placed on the Hardstand or participating in Club Events must be entered on the Club's Register (separate forms required) and can only be entered by a Full Member or equivalent, with appropriate paperwork.

Point Peron Hardstand

The Executive Officer is responsible for the allocation of the four metre bays to eligible Members only. The Cruising Yacht Club of WA Inc. shall not be liable for any loss, damage, destruction or injury incurred.

- **Point Peron Dingy Storage** (Full Members only): \$70 PA
- **Point Peron Gate Tag and Key** (Additional cost for any loss or damage—refundable on return of Tag and Keys): \$50 PA
- **Temporary Hardstand and Work Area fee:** (Per week)\$100
- **Temporary Hardstand Bay** (Full Members only): Quarter \$250

Club Moorings—West of Val Street Jetty

The Sailing Administrator and Executive Officer are responsible for the allocation of Club Moorings. The Committee of The Cruising Yacht Club of WA Inc reserves the right to order evacuation of Club Moorings as deemed reasonable by the Committee. The Cruising Yacht Club of WA Inc shall not be liable for any loss, damage, destruction or injury incurred. Seasonal moorings are only available between October to April for TCYC Members.

Per Season: \$600 under 9m, \$700 over 9m (Seasonal Moorings are for Full Members only. \$300 refundable bond required)

Per Month: \$200 under 9m, \$250 over 9m; **Per Week:** \$75; **Overnight:** \$15
