House Support Points (HSP)

In addition to Annual Membership fees, all voting members (other than Country) are required to purchase House Support Points (HSP), which are credited onto their Membership account once per year (in April) and are accessed by the Membership card, These are redeemable at the Club for Merchandise, Food and Beverages and expire on the 31st March if not redeemed. New Members who join between 1 December and 31st March will be eligible for a pro-rata discount on House Support Points.

Club Boat Register

All craft either moored, placed on the Hardstand or participating in Club Events must be entered on the Club's Register (separate forms required) and can only be entered by a Full Member or equivalent, with appropriate paperwork.

Point Peron Hardstand

The Hardstand Manager is responsible for the allocation of the bays to eligible Members only. The Cruising Yacht Club of WA shall not be liable for any loss, damage, destruction or injury incurred.

- **Hardstand Bay:** Voting Members - \$740 (Yearly) plus establishment fee (\$300) & Bond (\$250).
- **Small Hardstand Bay (<5m):** Voting Members - \$425 (Yearly) plus establishment fee (\$90) - No bond required.
- **Tender Dinghy Bay (<3.1):** Voting Members - \$80 (Yearly) plus establishment fee (\$20) - No bond required.
- **Undercover** (subject to limited availability) - E.O. \$80.
- **Hardstand Gate Keys:** \$50 (Refundable on return of Keys) - Additional cost for any lost or damaged keys.
- **Outboard Motor Container:** \$50 (Yearly) plus establishment fee and **Key Bond:** \$25 (Refundable on key return)
- **Temporary Work Area:** Voting Members - \$100/Week - Non Members \$250/week (Max stay 3 months)
- **Temporary Hardstand Bay:** Voting Members - \$100/month - Non Members \$250/month (Max stay 3 months)

Club Moorings—West of Val Street Jetty

The Hardstand Manager is responsible for the allocation of Club Moorings. The Committee of The Cruising Yacht Club of WA reserves the right to order evacuation of Club Moorings as deemed reasonable by the Committee. The Cruising Yacht Club of WA shall not be liable for any loss, damage, destruction or injury incurred.

Seasonal moorings are only available between October to April .
